Navigating PFAS Litigation: Securing Local Government Funds

The national PFAS litigation has resulted in settlements currently valued at more than \$12.5 billion. Ashley will share critical insights into the current settlements, future settlements, MDL status, significant deadlines, and the role of local government attorneys in protecting public health by securing financial resources for their communities.
