The 11th Annual Tennessee Bar Association Bankruptcy Forum will take place April 4 – April 6, 2014, at the beautiful Lodge at Buckberry Creek in Gatlinburg, Tennessee. Please make plans now to join us in this wonderful and relaxing setting for an informative and unique presentation of current issues of interest to a wide variety of bankruptcy attorneys. This high-quality program will begin with an update on the recent bankruptcy case developments in the Sixth Circuit and around the country. The program closes on Sunday with a three-hour session devoted to the ethical issues that arise in bankruptcy.
