

DISASTER AID CHECKLIST

Health Coverage

TennCare:

- Do you and your family members have health insurance?
- Did you lose your job and are you at risk of losing health insurance?
- Are there any healthcare services that you or a family member need but cannot get?
 - If yes, you may want to apply for TennCare. Please visit the Department of Human Services office in person, or call 1-866-311-4287, or apply online at <https://fabenefits.dhs.tn.gov/vip/website/signupservlet>

CoverKids:

- Covers many children who don't qualify for TennCare or other state insurance.

Unemployment Insurance

- Are you currently unemployed?
- Have you or will you lose your job due to the flood?
 - If yes, call 1-877-813-0950 or go to www.tennesseeanytime.org/labor to apply for benefits online.

Families First (also known as TANF)

- Families First provides cash assistance and TennCare.
- Do you live in a household with a child under age 19 with whom you're related by blood or marriage?
 - If yes, how much do you make before taxes? If it is below these amounts, you *may* be eligible.
 - Family of 1.....\$1,288
 - Family of 2.....\$1,658
 - Family of 3.....\$1,972
 - Family of 4.....\$2,240
 - There are also limits on the amount of resources you can have like cars, boats, savings, etc.
 - If you think you might be eligible, visit DHS in person or call 866-311-4287.

FOOD AID

Food Stamps (now known as supplemental nutrition assistance program, or “SNAP”):

- Are you having trouble putting food on the table?
- Is anyone in your household going without food?
 - If yes, how much do you make before taxes? If it is below these amounts, you *may* be eligible.
 - Family of 1.....\$1,174
 - Family of 2.....\$1,579
 - Family of 3.....\$1,984
 - Family of 4.....\$2,389
 - Family of 5..... \$2,794
 - Family of 6.....\$3,200
 - Family of 7.....\$3,605
 - There are also limits on the amount of resources you can have like cars, boats, savings, etc.
 - If you think you might be eligible, visit DHS in person or call DHS at 1- 866-311-4287 to apply.

FEMA (Federal Emergency Management Agency):

- Do you have losses in an area that has been declared a disaster by the president?
- Have you filed for insurance benefits and the damage to your property is not covered by your insurance or your insurance settlement is insufficient to meet your losses?
- Are you or someone who lives with you a citizen of the United States, a non-citizen national, or a qualified alien?
- Is the home in the disaster area where you usually live and where you were living at the time of the disaster?
- Are you not able to live in or get to your home now, or does your home require repairs because of damage from the disaster?
 - If yes, please contact FEMA 1-800-621-3362.
