Full Court Press: How Lawyers Can Effectuate Change

In 1976, Victoria Cape, a junior at Oak Ridge High School, filed a lawsuit against the Tennessee Secondary School Athletic Association, under Title IX of the Educational Amendments Act of 1972, and the Fourteenth Amendment. The issue was the TSSAA rules governing girls high school basketball at the time, limiting the girls game to half court, with the three forwards and three guards on each team, and the forwards and guards being confined to opposite ends of the court. At trial, Victoria Cape's lawyers called an expert witness, Pat Head, then a 26 year old head basketball coach of the University of Tennessee Lady Vols. She would go on to be the legendary Pat Summitt. The case would go to the United States Court of Appeals for the Sixth Circuit and ultimately to the Office of Civil Rights of the United States Department of Health Education and Welfare. The result would literally change the game and open the doors for young women to be student-athletes not only in Tennessee but across the country.
