10 - 11 a.m. CDT DUAL	Southern Frontlines: The Battle Against State-by-State Anti-LGBT Legislation - What's Working and What Isn't With the Equality Act stalled in the U.S. Senate, the battle for equality is being waged in the individual states - and in 30 of the 50 states at least one (and frequently several) bills have been introduced during the latest session that would roll back protections or, in some cases, not just restrict but eliminate protections for LGBT people. Some of the recent battles include attempts to rescind protections or make it illegal to offer medical care to transgender Americans, particularly those under the age of 18. Additionally, the rights of LGBT kids to be free from discrimination at school has become a target of many state legislators. This panel will examine the arguments being used to combat anti-LGBT legislation, what's working and what isn't, as well as possible developments for the next legislative session.
